## 2. Scope of Work

I will deliver work as outlined in the agreed proposal / estimate. Any changes beyond that scope may be subject to additional fees and adjustments to timeline.

## 3. Project Acceptance

Written approval of a quote, proposal or the commencement of work via email constitutes your agreement to these Terms and Conditions.

## 4. Deposits and Payments

A non-refundable 40% deposit is required before work begins. The remaining 60% is payable on project completion. The deposit payment secures my time on your project.

Final deliverables will not be released until all balances are cleared.

Payment is due within 7 days of invoice date unless otherwise agreed.

Overdue payments may incur interest in accordance with the UK Late Payment of Commercial Debts legislation.

## 5. Revisions and Amends

Each phase of a project includes up to two rounds of revisions unless otherwise agreed. Additional rounds or major changes outside the scope may incur extra charges.

## 6. Ownership and Copyright

Final, approved deliverables become your property once full payment is received.

All draft work, unused concepts, and design source files remain the property of SaltyAir Design unless a separate usage or 'buy out' agreement is in place.

## 7. Licensing

Any assets or content supplied by you must be cleared for commercial use. You hold responsibility for copyright compliance.

I reserve the right to showcase final work in the SaltyAir portfolio and social channels, unless otherwise agreed in writing.

## 8. Cancellation

Either party may cancel a project in writing. All completed work will be invoiced accordingly. Deposits are non-refundable once any work has commenced.

## 9. Liability

While I aim to deliver high-quality, strategic work, SaltyAir Design is not liable for indirect or consequential damages.

I am not responsible for third party service failures, such as hosting providers, printers, or domain registration services.

## 10. Project Delays
